(November 26-27, 2010)

Requirement for Entry:

Early Bird applications and booth fees must be received no later than Friday, October 15, 2010. All other applications and booth fees will be due no later than October 25, 2010. Please include a self addressed stamped envelope or email address (preferred) to mail your booth confirmation.

Booth Fee:

Booth fee is **\$75.00**. **Pay by Oct. 15th and get your booth for \$65.00**. Booths are 10'x10'. Payment in the form of check, money order or credit card (Visa/MC), must accompany your application. Please make checks payable to: **Angel Fire Community Center**.

Table Rental:

\$5.00 each. Tables are 6'x3'. Please indicate the number of tables you require on the application, and include table payment with your booth fee.

Electricity:

\$25.00/fee

Limited availability. Booths with electricity will be against the wall. Please indicate on your requirements on your application. We will provide extension cord(s).

Early Bird Set-up:

The center will be available for set-up from 9-5pm, Wednesday, November 24th. This is a good time for those that choose to set-up their booth early and avoid the busy Friday morning.

Regular Set-up:

Regular set-up will be the morning of the event from 7-9am. No set-up will be allowed after 9am, and there will be no refunds given. **You must be ready for the opening of the show at 10am.**

Tear Down:

There will be No Tear Downs prior to Saturday at 4pm.

REFUND POLICY:

Please notify us of your cancellation before October 31, 2010 and we will refund your booth fee in full. You will receive a 50% refund if you cancel by November 10. After the 10th, **no refunds will be given. No refunds will be given for inclement weather.**
